

PRESS NOTE

In compliance with the instructions of the Election Commission of India regarding the conduct of Special Intensive Revision (SIR) of Electoral Rolls, 2026, the Special Intensive Revision with 01.07.2026 as the qualifying date has been conducted in the State of Sikkim.

The details of the total number of electors in the State of Sikkim before the commencement of the Special Intensive Revision are as under:

Enumeration Forms (EFs) were generated and printed for all the existing electors and distributed through the Booth Level Officers (BLOs) across the State. Out of the total Enumeration Forms distributed, **4,33,242(91.99%)** Enumeration Forms were received back from the electors.

A total of **37,737(8.01%)** Enumeration Forms were not received back from the electors. Such electors were accordingly identified under the categories of Absentee, Shifted, Dead and Duplicate (ASDD), as applicable. The detailed breakup is as follows:

Draft Electoral Roll

The Draft Electoral Roll of SIR 2026 was published on 05.07.2026, containing a total of **4,33,294** electors. The gender-wise breakup is as follows:

Out of the total electors in the Draft Roll, **3,61,159** electors (**83.35%**) were mapped

with their own/parents' electoral details of the previous qualifying electoral roll/Last SIR, as applicable. Whereas, **72135** electors (**16.65%**) remained unmapped.

Out of **3,61,159** electors in the mapped category, **52,384** electors were identified as Logical Discrepancies (LD) by the ECI IT System under various categories.

Total **1,24,519** Notices were issued under the unmapped category and Logical discrepancies category. After proper hearing of all above cases total **16,485** electors found ineligible and **324** electors have been deleted upon submission of Form7 due to Death/shifted resulting in a total deletion of **16,809** electors during claims and objections period .

Hence Total electors who are going to be excluded from Final roll including both categories who did not submit EF back and found ineligible during hearing totals to **54,209 (37,724 ASDD + 16,485 ineligible)**

Final Electoral Roll of SIR 2026

The Final Electoral Roll of the Special Intensive Revision, 2026 is being published on 06.09.2026.

The total number of electors in the State of Sikkim as per the Final Electoral Roll is as follows:

Decisions in respect of the unmapped electors and cases of Logical Discrepancies were taken by the concerned Electoral Registration Officers (EROs)/Assistant Electoral Registration Officers (AEROs) after issuing notices and conducting hearings and/or collecting requisite documents and BLO undertakings, as per the provisions and facilities made available in ECINET by the Election Commission of India.

During the Claims and Objections period from 05.07.2026 to 04.08.2026, a total of **2,052** claims for new inclusions were received in Forms6, **16,867** objections were received in Form7 and **1,549** claims for correction/ shifting were received in Form8.

After due verification and disposal of the claims, objections, notices and cases relating to unmapped and discrepant electors, a total of **1,982** electors were added and **16,809** electors were deleted from the electoral roll. Out of the **16,809** deleted electors **16,485** electors were found ineligible during Notice and Hearing period and deleted.

The net change in the Final electorate is **-14,827**, representing a change of **-3.42%** over the previous Draft roll.

The Final Electoral Roll has been prepared after due consideration of claims, objections, notices, hearings and verification processes prescribed by the Election Commission of India.

The Final Electoral Roll of SIR 2026 is published on the website of the Office of the Chief Electoral Officer, Sikkim, at www.ceo.sikkim.gov.in on 06.09.2026 and displayed at all Polling Stations in the State. The Final Electoral Roll will also be available for public inspection at the offices of the Electoral Registration Officers and Assistant Electoral Registration Officers. Further, any person aggrieved by the decision of the Electoral Registration Officer may prefer an appeal before the competent appellate authority within the prescribed period under Section 24 of the Representation of the People Act, 1950 read with Rule 27 of the Registration of Electors Rules, 1960.
